#### Position of the stand

The position of the stand will be determined on the basis of free space using the "First Come, First Served" method. The stand closure agreement must be forwarded by e-mail to ensure the selected location. Upon receipt of the agreement, the location will be confirmed and invoice will be sent by e-mail.

## **Delegate registration**

For each stand, the company is entitled to receive 2 presenter name tags (including coffee and cake breaks and lunch).

#### **Guidelines letter to presenters**

- The organizing committee is required to request that the display be removed/replaced if its nature is incompatible.
- The organizing company is not responsible for equipment, inventory, or any damage caused to the equipment that arrived with you and not invited by the organizing company.
- In the event of cancellation, for any reason, after signing a contract, the payment will not be refunded for the stand.
